1. Copy of NTB Certificate;
2. Written proof of the landowner's authorization for long-term (minimum of 12 months) exclusive hunting rights for leopards, stating the name of Professional Hunter (PH), Master Hunting Guide (MHG), and Hunting Guide (HG) to conduct the hunt;
3. The latest copy (not more than two years old) of the Land Tax Assessment or a letter from the City of Windhoek, if the farm is located within Windhoek municipal area;
4. Founding statement indicating list of shareholders in the business entities, (in case a farm applied for is registered as a **CC** or **PTY**, showing their Percentage Interest and Nationalities). In the case of a farm registered in a trust, a list of trustees is required;
5. Proxy letter for the nominated person to handle applications (in case of a farm which is registered as a CC, PTY or a trust).
6. A valid copy of the registration certificate as a Professional Hunter, Master Hunting Guide, or Hunting Guide of the applicant (also include registration certificates of all guides, MHGs, and PHs registered under or employed by the safari company, along with their employment letters) to conduct the hunt.
